Barbara was appellant's counsel in the landmark case *Pleasant v. Pleasant*, 97 Md. App. 711, 632 A.2d 202 (1993), which established that Maryland courts can award a survivor benefit annuity to a spouse when dividing a pension. She has significant experience with closely held corporations and professional practices, both in their valuation in the divorce context and in shareholder disputes.

Barbara has a long-standing commitment to pro bono service. She is the founding mentor of the Pro Bono Family Law Clinic, which has served scores of low-income clients in Prince George's County since its creation in 2000. In 2008, Barbara and JGL received the annual award for pro bono service from Community Legal Services of Prince George's County. In 2009, Barbara created and managed the Thousand Hours Project, which donated 1,000 hours of pro bono legal services to homeowners struggling in the foreclosure crisis that was sweeping over Maryland. Barbara and JGL received the Beacon of Justice Award from the National Legal Aid and Defenders Association in 2009 for this project. In 2009, Barbara received the Herbert S. Garten Award for pro bono service by the Maryland State Bar Association. She is a former member of the board of directors of the Pro Bono Resource Center of Maryland.
