## **Main Causes of Explosion and Fire Accidents**

Fires and explosions have many potential causes. Home and property fires can be caused by electrical events, defective home equipment and appliances, and natural gas and propane leaks, among other sources. When a home catches on fire or suffers an explosion event, not only can the property be devastated but the individuals in and around the home can be catastrophically injured.

In addition, there is a rising incidence of explosions and fires caused by lithium-ion batteries, including those found in smartphones and tablets, electronic cigarettes and vaping devices, power tools, and even vehicles. Lithium-ion battery explosions can cause severe thermal injuries in people and can also destroy homes and property.

# **Common Injuries Related to Fire and Explosion Accidents**

Commonly, individuals exposed to fires and explosions suffer burns on their body. Burns can result in severe pain, permanent scarring, loss of mobility, permanent numbness, and other disabilities. Fires and explosions can also result in smoke inhalation, which can cause pulmonary and cardiovascular injuries, which can be chronic and permanent. Explosions, in particular, can cause other types of injuries, including traumatic brain injury and orthopedic injuries (such as fractures/breaks and joint dislocations, for example), which can be life-altering and require extensive rehabilitation. At their most tragic, fires and explosions can be fatal.

#### Who is Liable for Fire and Explosion Accidents?

Fires and explosions can have many different causes, and no case is the same. We investigate fires and explosions caused by products that have been defectively designed or manufactured, such as home appliances, HVAC equipment, and lithium-ion batteries. In such cases, the manufacturer of the product may be liable for their failure to distribute a reasonably safe product. Our attorneys also investigate fires and explosions caused by natural gas or propane leaks. Gas leaks may be caused by defective or faulty gas tanks or lines, or may be caused by a gas company's failure to properly inspect or address a problem with the gas system.
